WHEREAS: The Table of Organization of the HFD is now one (1) Fire Chief, four (4) Battalion Fire Chiefs, ten (10) Fire Captains, and twenty-seven (27) Fire Fighters; and

WHEREAS: As a result of several retirements in the HFD, it was not necessary to effectuate the Layoff Plan; and

WHEREAS: As a result of these retirements, there will be one (1) vacancy in the rank of Fire Captain, effective August 1, 2010; and

WHEREAS: Fire Fighter James Lawless is number one (1) on the Fire Captain List, Symbol PM 3593J.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Harrison, Hudson County, New Jersey, as follows:

WHEREAS: The Town of Harrison has not adopted the Local Municipal Budget for 2010 pending approval from the Local Finance Board, and the Tax Collector will not be able to mail the Town's 2010 Tax Bill on a timely basis; and

WHEREAS: The Tax Collector, in consultation with the Town Treasurer, has computed an estimated tax levy in accordance with N.J.S.A. 54:4-68.3, and they have both signed a certification showing the taxes levied for the previous year, the tax rates, and the range of permitted estimated tax levied; and

WHEREAS: In accordance with Chapter 72, P.L. 1994, the Mayor and Town Council request the Director of the Division of Local Government Services to approve the estimated tax levy at 105% listed below. Approval will enable the Town to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments, and save the unnecessary cost of interest expenses on borrowing.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Harrison, Hudson County, New Jersey, as follows:

THAT: The Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Town for the third installment of 2010 taxes. The Tax Collector shall proceed upon the approval from the Director of Local Government Services and take such actions as are permitted and required by P.L. 1994 c.72 (N.J.S.A. 54:4-66.2 and 54:4-66.3); and

THAT: The entire estimated tax levy for 2010 is hereby set at \$ 28,549,044.63; and

THAT: In accordance with law, the third installment of 2010 taxes shall not be subject to interest until the later of August 10th or the twenty-fifth calendar day after the date the estimated tax bills are mailed.
