**RE: Passaic Valley Sewerage Commission (PVSC) Sewer Project
Kingsland Avenue between Hamilton St. and Harrison Ave.**

Dear Resident:

In December of 2023, the Town hosted a public forum for residents regarding PVSC's extensive sewer project under Kingsland Avenue between Hamilton St. and Harrison Ave (the "Project"). This Project is necessary for the continued health and safety of the Town's residents. Unfortunately, the Project will take approximately 8 months to complete, and will require that portion of Kingsland Avenue to be closed to vehicles for most of the Project. Included herein is a "Construction Notice" from PVSC explaining the Project, as well as a Public Service Announcement/Reverse 9-11 message for residents.

While some mobilization/pre-construction activities will start as early as next week, excavation/closure of the subject portion of Kingsland Avenue will not begin right away.


In order to accommodate the temporary loss of parking spaces along Kingsland Avenue, the Mayor & Council in coordination with the Harrison Police Dept. have designated parking by Special Permit along the eastern curb of Supor Blvd. from Ann St. to Wilhelm St. In order to use these parking spaces, residents of #1 to #26 Kingsland Avenue MUST obtain a Permit from the Harrison Police Traffic Safety Bureau between 8:30AM and 4:00PM (Mon.-Fri.). Any vehicle without a Special Permits is subject to ticketing/towing.

CONSTRUCTION NOTICE

PVSC's Kearny-Harrison-Newark (KHN) Branch Interceptor Sewer to be Rehabilitated within the Town of Harrison

Construction Work on Kingsland Avenue between Hamilton Street and Harrison Avenue

Dear Resident:

This notice is to inform you that the Passaic Valley Sewerage Commission (PVSC) has contracted with Montana Construction, Inc. (Montana), to rehabilitate its Kearny-Harrison-Newark (KHN) Branch Interceptor Sewer within the Town of Harrison. Construction activities are planned to occur within the following construction site location:

Kingsland Avenue between Hamilton Street and Harrison Avenue within the Town of Harrison.

Construction activities are scheduled to begin in your area **the week of March 11, 2024 or shortly thereafter**. Working hours are from 7:00 a.m. to 3:30 p.m. Monday through Friday, **except during the actual rehabilitation work, which may require extended work hours**. During construction, your sewer service **will not** be interrupted. If you have any concerns, please do not hesitate to bring them to our attention.

Motorists should expect some minor delays within and around the construction work zone and are encouraged to use alternate routes or to plan additional travel time.

The anticipated duration of the construction work activities is estimated to be approximately **Eight Months** for the **removal and replacement work** and the **cured-in-place pipe (CIPP) lining work** based on the contractor's construction schedule and resources.

Esta notificación es para informarles que Passaic Valley Sewerage Commission (PVSC) contrato a Montana Construction, Inc. (Montana) para rehabilitar Kearny-Harrison-Newark (KHN) La alcantarilla interceptora secundaria de la Ciudad de Harrison. Planeamos comenzar con actividades de construcción en la siguiente ubicación:

Kingsland Avenue entre Hamilton Street y Harrison Avenue dentro de La Ciudad de Harrison.

Actividades de construcción están programados para comenzar en su área **Marzo 11, 2024 o poco después**. El horario de trabajo es de las 7:00 a.m. a 3:30 p.m. de Lunes a Viernes, **excepto durante el trabajo de rehabilitación real, que puede requerir horario de trabajo extendido**. Durante la construcción su servicio de alcantarillado **no será** restringido. Si tiene alguna inquietud, no dude en comunicárnosla.

Automovilistas deben esperar retrasos menores dentro y alrededor de la zona de obra de construcción y se les recomienda utilizar rutas alternativas o planificar tiempo de viaje adicional.

Se estima que la duración prevista de las actividades de construcción será de aproximadamente **Ocho Meses** para los trabajos de eliminación & reemplazo y cura de tuberías basado en el cronograma de construcción y los recursos del contratista.

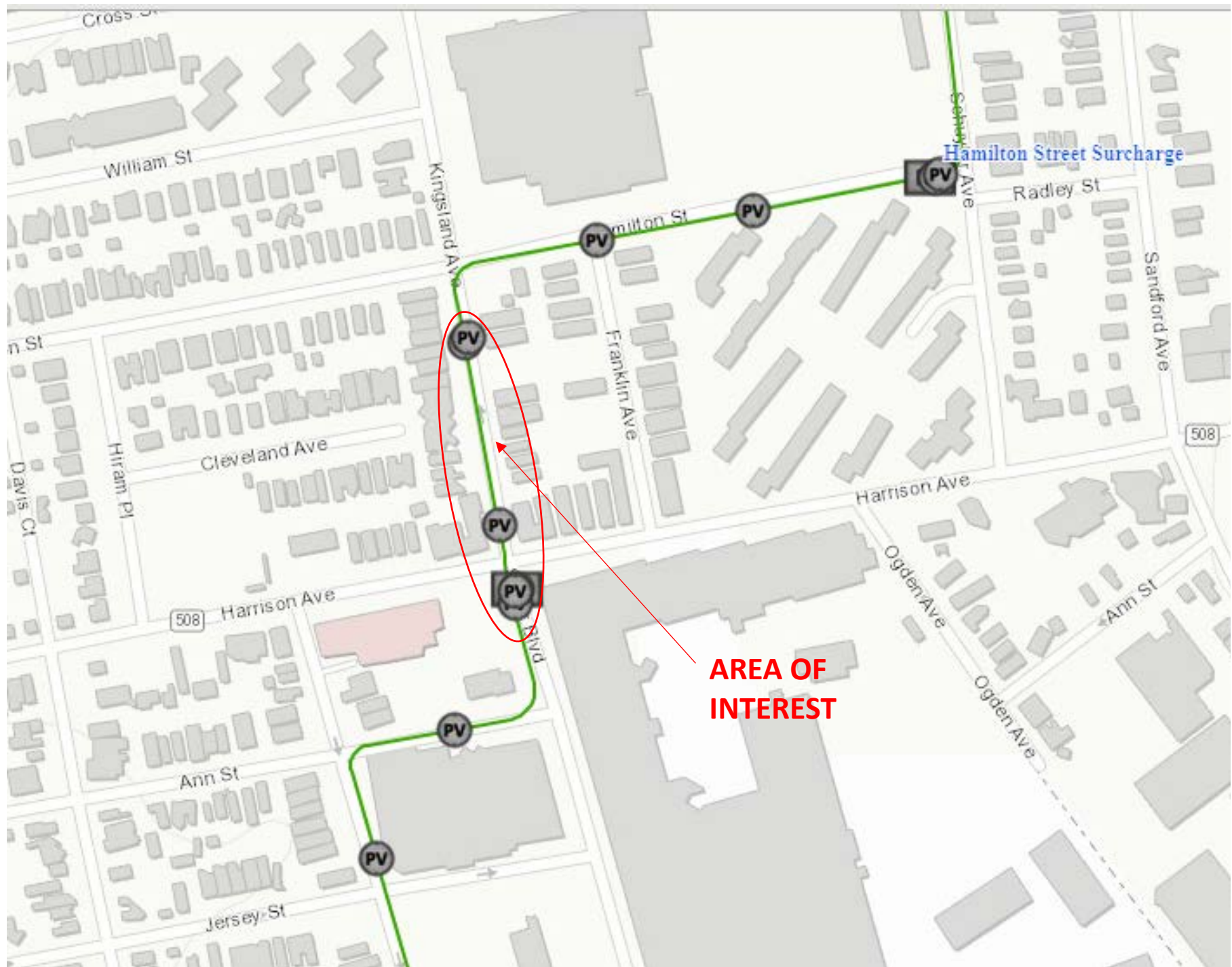

PUBLIC SERVICE ANNOUNCEMENT

This is a message from Mayor James A. Fife and the Harrison Town Council.

The Passaic Valley Sewerage Commission, also known as PVSC, needs to perform extensive work on its Branch Interceptor Sewer under Kingsland Avenue between Hamilton Street and Harrison Avenue. This Project is scheduled to start shortly and is expected to last approximately 8 months. During the Project, Kingsland Avenue will be closed to vehicles.

The Town and PVSC held an open forum this past December where Harrison residents had the opportunity to ask questions and learn about the Project.

A Construction Notice from PVSC is posted on the Town website's homepage at www.townofharrisonnj.com.

In order to protect the properties along Kingsland Avenue from possible settlement from the required excavation, PVSC has contracted with Kilduff Underground Engineering to survey the interiors and exteriors of said properties. A "survey" form will be mailed to the property owners.

Finally, during construction Kingsland Avenue residents affected by the Project will be permitted to park their vehicles on east side of Supor Blvd. between Ann and Wilhelm Streets. Residents must obtain a Permit from the Harrison Police Traffic Safety Bureau during business hours.
