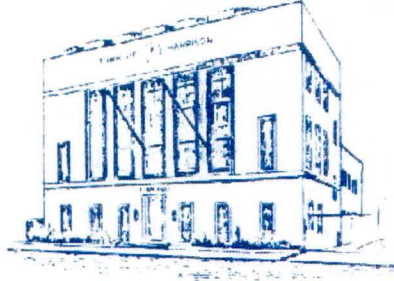

When you hear your name announced during the public comment portion of the Meetings, you may address the Mayor. After a speaker's time expires, that individual's microphone will be muted to allow other speakers the opportunity to address the Mayor. Each user will have the capability to participate via audio only.

Members of the public may also submit written comments in advance of the Meetings, which will be read and addressed during the public comment portion of the Meetings. Such comments may be submitted via e-mail to pizarbetski@townofharrison.com or by written letter addressed to Paul J. Zarbetski, Town Clerk, Harrison Town Hall, 318 Harrison Avenue, Harrison, NJ 07029. All such comments must be received at least 2 hours prior to the scheduled starting time of the Meetings.

Whether made during the Meetings or submitted in writing prior, all public comment requires the person's name and complete address. There is a 5 minute limit on all public comment, which may be extended by the chairperson as needed.
